21	FACTS					
22	In the instant case, the defense or	n numerous occasions has				
23	advised the court of the desire to request a change of venue					
24	based on the amount of pretrial publicity that this case has					
25	received. In order to prepare for this eventual motion, the					
26	People have retained the services of an expert in the area of					
27	venue surveys. The People's expert intends to conduct a venue					
28	survey to test the attitudes of potential jurors in Stanislaus					

County and around the state. The expert has suggested that the People adopt a procedure that was used in Ventura County and which resulted in a significant cost savings to the taxpayers. That procedure provided for the venue survey to be submitted to potential jurors that had already been summoned for jury duty in unrelated cases. By using this procedure, the surveys are guaranteed to only come from "qualified jury candidates" and that extensive and expensive phone surveys are avoided.

ARGUMENT

The People have retained as their expert Dr. Ebbe Ebbesen, Professor of Psychology, University of California, San Diego. Dr. Ebbesen's curriculum vitae is attached as Exhibit "A". In addition to working on numerous other cases throughout the United States, as set forth in his curriculum vitae, Dr. Ebbesen was the expert retained in the Sonoma County case against Richard Allen Davis case who was convicted and sentenced to death for the murder of Polly Klass. Dr. Ebbesen designed his own jury survey in that case as well as many others.

Dr. Ebbesen has testified in courts in this state and others as an expert in the fields of public opinion surveys, change of venue motions, and the design and interpretation of such surveys. He has been a witness in over 95 cases, including approximately 30 change of venue motions, and consulted in many others.

Dr. Ebbesen is designing the jury survey to be used by the prosecution in this case. Based upon his expertise in this area, he will design questions for very specific reasons that directly relate, in his opinion, to the extent of publicity in this case

and the effect of that publicity on the public to be fair and impartial as jurors. This survey will be designed to measure several aspects of potential juror 'mental content' relevant to whether the publicity in this case has been so extensive, inflammatory and prejudicial that there is a reasonable likelihood that, absent a change of venue, the defendant would not be able to receive a fair trial.

The People, as well as the defense, are entitled to conduct a public opinion survey in preparation for a hearing on a change of venue motion. (Maine v. Superior Court, (1968) 68 Cal. 2d 375, 383; California Criminal Law, Procedure and Practice, Fifth Ed. Section 16.12 and 16.19.)

It is imperative in such a survey that the parties determine if prospective jurors are open to altering their opinions when presented with a series of new facts, as opposed to refusing to do so because of pre-trial publicity. It is not necessary that jurors be ignorant of prejudicial publicity, or that they have not formed an opinion concerning defendant's culpability. It is only necessary that they be willing to set aside all impressions and base their verdict only on the evidence presented in court. (People vs. Harris, (1981) 28 Cal. 3d 935, 949.)

Procedure

The procedure that the People suggest that this court allow is a a procedure used by Dr. Ebbesen in the case of <u>The People of the State of California vs. VINCENT HENRY SANCHEZ</u>, Ventura County Superior Court Number 2001900034. In the <u>SANCHEZ</u> case, the court allowed the prosecution and the defense to submit their own

independent jury surveys to summoned jurors waiting to be called for other cases, much like our jurors wait until they are called to a courtroom. The parties provided the surveys and pencils to the jury staff for distribution over a two-week period of time (one week for each party) and collected the surveys when completed at the end of the day. The jury staff read a statement similar to this:

"The Ventura County Superior Court has authorized the circulation of a survey regarding a case you may have heard or read about. The court has asked for volunteers to complete this survey. You will not be called as a juror in this case.

The survey form must not be taken out of this room and must be completed and returned today. Please do not discuss the questions or your answers with anyone else in this room before you have completed and turned in your survey. Please do not disclose the content of this survey or your responses to friends or family. The disclosure of survey questions and your answers could affect the ability to be fair and impartial of those people who will serve as actual jurors in the case described in this survey.

All of your answers are confidential. We do not know your name and please do not write it on the jury survey form. Please do not remove the cover sheet as the survey forms are numbered."

The People request that the Court permit the People to design and use our own survey, relying heavily on our expert, Dr. Ebbesen, as to the appropriate and necessary content, analysis and conclusions, and to allow us to conduct the survey, following the same procedure used in Ventura County, with the Jury Commissioner's Office here in Stanislaus County. The People also request a court Order to authorize us to do this in at least two other counties in the state, with the permission of the court in each county. It is the People's intent to do this prior to the preliminary hearing.

Conclusion

The People request that this court grant an Order for a jury survey in this county with the Jury Commissioner's Office, and to conduct at least two in other counties with the permission of the court of those counties.

For all of the above-cited reasons, the People request the court to grant such an Order.
