The Coroner's Division of the Contra Costa County Sheriff-Coroner's Office 15 ("Coroner") is ordered to permit a defense radiologist expert selected by Mark J. Geragos and/or 16 Kirk McAllister to x-ray the remains of the baby Conner Peterson. 17 2. The x-rays will be taken at the Coroner's facility at 1960 Muir Road, Martinez, 18 August 22 Dek 29
California, no later than September 5, 2003, at a time mutually agreed to by the defense, the 19 People, and the Coroner. 20 3. Only the following persons may be present at the x-ray examination: 21 Up to four persons for the defense (radiologist, experts, 22 а. counsel, and support persons). 23 Up to two persons chosen by the Stanislaus County District b. 24 Attomey's Office. 25 Up to two Coroner officers (to maintain security and the C. 26 chain of custody of the remains). 27 A physician selected by the Coroner.

1	4. The defense shall be permitted to use the Coroner's x-ray equipment.
2	5. The defense shall not be responsible for the costs of having the persons identified in
3	subparts (b) through (d) of paragraph three attend the examination. Moreover, the defense shall
4	not be charged for the use of the Coroner's x-ray equipment or facility.
5	6. Two x-rays will be taken of each position. One x-ray will be furnished to the defense;
6	and one x-ray will be furnished to the People.
7	Release of Remains to Next of Kin
8	August 22 of the 1. After the taking of the x-rays or September 5 , 2003, whichever is sooner, the Coroner
9	is authorized to release the remains of Laci Peterson and the baby Conner Peterson to the next of
10	kin.
